Principal Accountabilities

- 4. To acquire diagnostic images, and physically position the full range of patient presentations, accurately for examinations, taking into account patient limitations and adapting standard techniques where necessary.
- 5. Maintaining a high level of technical and theoretical skills through personal CPD.
- 6. To be able to set up and clear a basic sterile trolley for interventional procedures.

- 7. To be familiar with the range of technical applications available on imaging equipment.
- 8. Undertake any other duties as required by the line manager.
